

**FREE AGENT RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK,
AND INDEMNITY AGREEMENT ("AGREEMENT")**

I, the undersigned, wish to participate in various baseball training activities, exercises and workouts at the Braves Tryout Camp (hereinafter known as "Tryout Camp") as organized by **Atlanta National League Baseball Club, Inc.** (hereinafter known as "Braves").

In consideration of the opportunity to participate in the Camp, I hereby acknowledge, understand, accept and agree that:

I understand the nature of this Tryout Camp and am qualified, in good health, and in proper physical condition with no physical limitations or health issues that would prohibit or impair my ability to participate in the Tryout Camp. I have obtained a letter and/or certification from a licensed physician verifying my statement of health.

I understand the risks involved with my participation in the Tryout Camp include, but are not limited to, the risk of serious bodily injury, permanent disability, paralysis and death, which may be caused by (i) my own actions or inactions and those of others participating in the Camp, (ii) the conditions in which the Camp takes place, and (iii) the negligence of the Released Parties defined below. I knowingly and freely assume all such risks, both known and unforeseen, even if arising from the negligence of the Released Parties. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Tryout Camp activities. I hereby accept full responsibility for any such injury or damage to my person or property that may result from my participation.

I hereby release, forever discharge, and covenant not to sue the Braves, its parent, subsidiary and affiliated companies, its officers, employees, volunteers, scouts, trainers, players and coaches, other participants, and any sponsors, advertisers and owners or lessors of premises on which the Tryout Camp takes place (each considered one of the "Released Parties" herein), from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by my participation in the Tryout Camp, including from the negligence of the Released Parties. I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Released Parties, I will indemnify and hold harmless each of the Released Parties from any loss, liability, damage, or cost which may be incurred as the result of such claim.

I have read this FREE AGENT RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I will be giving up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature. I intend for this Agreement to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
